Modeled on successful structures in other professional societies, this group could launch a dedicated #AGSFIT social media campaign and a quarterly enewsletter to celebrate our members' publications, presentations, and awards, thereby increasing the visibility of trainee contributions to the field.

My goal as Co-Chair would be to empower my fellow trainees, strengthen our community, and ensure the FIT Section is a dynamic and indispensable part of the American Geriatrics Society.
